MEMO

The admission process is currently underway for various classes across all Vidyajyoti Schools. Admissions from Nursery to Class 5 are being conducted through a lottery system. However, for admissions in Classes 6 to 9 against available vacancies, **Screening Tests** will be conducted.

For conducting Screening Test, following guidelines will be followed:

Scheme of Examination:

- Screening Test will be held on 02/05/2025 for the Academic Session 2025-26.
- Question Papers shall be prepared bilingual, i.e. in English & Bengali.
- There shall be 3 sets of Question Papers, viz. A, B & C in double Crown Size paper.
- The Question Paper shall be framed in MCQ pattern and based on Learning outcome prescribed by the NCERT.
- Mathematics, Science and English will be taken as subject for screening test.
- The Syllabus of previous class i.e. for class VI, question paper will be prepared covering whole syllabus of class V of the concerned subject.
- For Class VII, the question paper will be prepared covering the syllabus of class VI of the concerned subject.
- For class VIII, the question paper will be prepared covering the syllabus of class VII of the concerned subject.
- For class IX, the question paper will be prepared covering the syllabus of class VIII of the concerned subject.
- Questions will be prepared for 100 (hundred) marks and time will be allowed 3 hours and 15 minutes.

Marks distribution:

Maths-	40 marks
Science/ EVS -	30 marks
English -	30 marks

For **English**, marks Distribution will be as follows:-

Reading Skill:	10 marks
Writing Skill:	10 marks
Grammar:	10 marks

- Date of Examination (Screening Test for classes VI- IX) : 02/05/2025
- Time schedule - 11 am 02:15 pm – (3 hours 15 minutes)
- Publication of Result : 03/05/2025.
- Admission will be completed by : 06/05/2025.


Procedure of declaration of result:

- A **Panel** shall be prepared based on the marks obtained by the aspirants.
- Admission will be given against vacant seats **as per the reservation roster**.
- If any candidate fails to take admission within the stipulated time, the **next eligible candidate** from the panel (under the same category) will be considered.
- The **Answer Key** will be provided by the Directorate of Elementary Education (DEE) immediately after the examination, via email to the respective DEOs for circulation.
- **Evaluation** will be conducted by the respective schools.
- The **list of selected candidates** must be displayed on the school's notice board and school's website.
- The **final selection** will be made by the respective school.
- Any **grievance** regarding the result must be submitted to the respective school within **2 days** of result declaration. The grievance, if any, shall be settled by the Principal of the said school in coordination with the Observer assigned by the District Education Officer (DEO).

In this regard, all the District Education Officers are requested to instruct all the Principals to ensure the fair and smooth conduction of the entire admission process. The Headmaster/Headmistress of the nearest Senior Secondary Government Non-Vidyajyoti School of each examination centre may be assigned by the DEOs to act as an observer of the entire examination process until the completion of the evaluation and the publication of the merit list on both the school notice board and the school website.
